Qualifications to Be the Trainee

The trainee shall be a citizen of a developing country and must meet all the conditions below.

- (1) A person who is engaged in an occupation necessary for economic, social and cultural development of his/her country, and has the will and potential to become a mid-level leader in his/her professional field in the future.
 - * After returning from Japan, he/she must take up work of the same field as the training he/she will have completed in the same organization he/she belonged to before.
- (2) A person who has been working in the current organization for one year or over as of January 1, 2023, in the field which he/she wishes to receive training, and has enough basic knowledge and considerable experience to receive the training in that field.
- (3) In principle, a person who has enough Japanese language competency in both listening and speaking to receive training in Japanese.
- (4) A person who is healthy enough, both mentally and physically, to receive training, and who does not have any obstacle to receiving training, and who can come to Japan without his/her family.
- (5) A person who is 18 years old and over, and under 40 years old as of August 1, 2023, and whose nationality is not Japanese.
- (6) A person who has never received any kind of criminal punishments or administrative disposition, such as enforced repatriation, due to violation of the Japanese laws or regulations.

Methods of Specialized Training

- The specialized training is conducted in the form of practical training based on the regular work activities of organizations such as educational institutions.
- In principle, the specialized training is conducted in Japanese. (Interpreter is not available.)

Training Expenses and Accommodations

- Accommodations: To be designated by K.P.G.
- Expenses of training: K.P.G. shoulders the following expenses necessary for the training.
- (1) Travel expenses to and from Japan: Round-trip, economy class ticket for the shortest route between the trainee's nearest international airport and Narita Airport, etc.
- (2) Expenses to stay in Japan: Expenses of living, accommodations, and accident insurance, etc.
- (3) Travel expenses in Japan: Travel expenses between Narita Airport, etc. and the designated accommodation at the time of arrival in and departure from Japan, and commuting expenses between the accommodation and the specialized training organization.

Screening

K.P.G. will conduct screening of the trainees based on the information entered in the application documents and whether there are suitable training organizations for the desired training fields. We will inform the selected trainees of the result through the recommending organizations.

Application method By e-mail and by post (both necessary)

Deadline Documents sent by e-mail must arrive by no later than April 28 (Fri.), 2023 and documents sent by post must arrive no later than May 15 (Mon.), 2023

Screening and notification of the result Mid-June 2023

Notes

*The program may be canceled or the contents may be changed depending on the situation of the COVID-19 infections and quarantine measures taken by the national government. K.P.G. will not shoulder the preparation cost when the trainee is unable to enter Japan due to cancellation.

*To enter Japan, it is required to present an effective vaccination certificate (you must have received three doses of designated vaccine, etc.) or a document to prove that you test negative at the test taken whitn 72 hours before departure. Please understand beforehand that the requirements for entering Japan are subject to change. You are required to follow the latest quarantine measures taken by the national government of Japan.
